This stock option vests over four years, with the first 25% of the shares vesting one year from the grant date and 75% of the shares

  - (2) The right to exercise this non-qualified stock option to purchase 98,520 shares of Genentech common stock is held by the ex-spouse of the reporting person pursuant to a domestic relations order.
