- (1) Includes 34,357 restricted stock units (RSUs) mandatorily deferred by the Company from Mr. Harvey's annual discretionary bonus, plus 8,589 RSUs granted to Mr. Harvey as a Company match on his mandatory bonus deferral. These RSUs will generally vest ratably over four years. Also includes 19,996 RSUs voluntarily deferred by Mr. Harvey from his annual discretionary bonus, plus 4,999 RSUS granted to Mr. Harvey as a Company match on his voluntary bonus deferral. These RSUs will generally be delivered on the third anniversary of grant. Also includes 10,907 RSUs that vest ratably over five years.
- (2) Represents the withholding by the Company of a sufficient number of shares of common stock to satisfy Mr. Harvey's tax obligations upon the vesting of 12,435 previously reported RSUs.
