Mexico City, Mexico – November 18, 2016 –Coca-Cola FEMSA, S.A.B. de C.V. (BMV: KOFL; NYSE: KOF) (“Coca-Cola FEMSA” or the “Company”) has refiled with the Mexican Stock Exchange (Bolsa Mexicana de Valores, S.A.B. de C.V.) and the Mexican National Banking and Securities Commission (Comisión Nacional Bancaria y de Valores) the corresponding notes to the financial statements of the third quarter results of 2016. This change does not involve any changes to the figures reported previously, but implies changes in the notes and its corresponding titles.
