(a) Amount Beneficially Owned:

As of the date of this filing, Integrated Core Strategies (US) LLC, a Delaware limited liability company ("Integrated Core Strategies"), is the beneficial owner of 112,600 shares of the Company's Common Stock. Integrated Core Strategies also holds 3,252,725 warrants to purchase the Company's Common Stock. Each warrant will entitle the holder to purchase one share of the Company's Common Stock at a price of \$7.00 ("Warrant"). Each Warrant will become exercisable upon the Company's completion of a business combination, provided that the Company has a registration statement under the Securities Act in effect covering the shares of Common Stock issuable upon the exercise of the Warrants and a current prospectus relating to the Common Stock. While the Company consummated a merger on March 31, 2009, as of the date of this filing, the Company does not have an effective registration statement and therefore, the Warrants are not currently exercisable.

Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. Israel A. Englander ("Mr. Englander") is the managing member of Millennium Management. Consequently, Mr. Englander may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies.
