Item 8.01 Other Events.

On June 8, 2012, Aircastle Limited (the "Issuer"), completed its offer to exchange up to \$500 million of its outstanding 6.75% Senior Notes due 2017 (the "2017 Original Notes") for 6.75% Senior Notes due 2017 that have been registered under the Securities Act of 1933, as amended (the "2017 New Notes") and to exchange up to \$300 million of its outstanding 7.625% Senior Notes due 2020 (the "2020 Original Notes" and, collectively with the 2017 Original Notes, the "Original Notes") for 7.625% Senior Notes due 2020 that have been registered under the Securities Act of 1933, as amended (the "2020 New Notes" and, collectively with the 2017 New Notes, the "New Notes"). The exchange offer was made in order to satisfy certain obligations of the Issuer contained in a Registration Rights Agreement, dated as of April 4, 2012.

The exchange offer expired at 5:00 p.m., New York City time, on June 6, 2012. All \$300 million in aggregate principal amount of the 2020 Original Notes were exchanged and \$498.9 million in aggregate principal amount of the 2017 Original Notes were exchanged. The New Notes are substantially identical to the Original Notes, except that the New Notes have been registered under the Securities Act of 1933, as amended, and, as a result, the transfer restrictions and registration rights provisions applicable to the Original Notes do not apply to the New Notes.
