Item 1.01. Entry into a Definitive Material Agreement

On May 7, 2012, Wells Timberland REIT, Inc. (the "Registrant"), through a wholly owned subsidiary, entered into a purchase and sale agreement (the "Agreement") with a purchaser that is not affiliated with the Registrant to sell approximately 4,700 acres of timberland for approximately \$8.3 million, exclusive of adjustments and closing costs.
