On December 31, 2012, 66,667 restricted stock units held by Mr. Morhaime vested. Pursuant to the terms of his restricted stock unit award agreement, the Company withheld 31,121 of the shares otherwise deliverable to him in order to satisfy the resulting tax withholding obligation.
  - (1) Following the receipt thereof, Mr. Morhaime transferred the net shares he received in connection with the vesting of his 66,667 restricted stock units to the Michael Morhaime Revocable Trust.
  - (2) Following the transactions reported on this Form 4, Mr. Morhaime directly held 406,665 restricted stock units, each representing the right to receive one share of the Company's common stock.
  - (3) Following the transactions reported on this Form 4, Mr. Morhaime indirectly held (through the Michael Morhaime Revocable Trust) 108,415 shares of the Company's common stock.
  - (4) These securities are held by the Michael Morhaime Revocable Trust.
  - (5) Following the transactions reported on this Form 4, Mr. Morhaime indirectly held (through his wife) (a) 1,076 shares of the Company's common stock and (b) 13,749 restricted stock units, each representing the right to receive one share of the Company's common stock.
