# SCHEDULE 13G/A

This Amendment No. 3 (this Amendment ) to Schedule 13G (the Schedule 13G ), relating to shares of Common Stock, par value \$0.001 per share (the Common Stock ), of Dolan Media Company, a Delaware corporation (the Issuer ), is being filed on behalf of TCS Capital GP, LLC, a Delaware limited liability company ( TCS GP ), TCS Capital Investments, L.P., a Cayman Islands exempted limited partnership ( TCS Offshore ), and Eric Semler the principal of TCS GP.

This Amendment relates to shares of Common Stock of the Issuer (A) purchased by Eric Semler, and TCS GP for the accounts of (i) TCS Capital, L.P., a Delaware limited partnership (TCS Capital), (ii) TCS Capital II, L.P., a Delaware limited partnership (TCS Capital II), and (iii) TCS Offshore and (B) held by TCS Offshore. TCS Capital holds 221,790 shares of the Common Stock, TCS Capital II holds 965,697 shares of the Common Stock, and TCS Offshore holds 1,817,759 shares of the Common Stock. TCS GP acts as general partner to each of TCS Capital, TCS Capital II and TCS Offshore, and Mr. Semler, as manager of TCS GP, controls the investment decisions of TCS GP. This Amendment is being filed to amend and restate Item 4 of the Schedule 13G as follows:

# Item 4 Ownership.

- (a) TCS GP (as the general partner of TCS Offshore, TCS Capital II and TCS Capital) and Eric Semler (as the principal of TCS GP) are the beneficial owners of 3,005,246 shares of Common Stock. TCS Offshore is the beneficial owner of 1,817,759 shares of Common Stock.
- (b) TCS GP and Eric Semler are the beneficial owners of 10.0% of the outstanding shares of Common Stock. TCS Offshore is the beneficial owner of 6.1% of the outstanding shares of Common Stock. The denominator for calculating these percentages is 29,952,921, the number of shares of Common Stock issued and outstanding as of November 7, 2008, as reported in the Issuer s Form 10-Q filed on November 12, 2008.
- (c) As the general partner of TCS Offshore, TCS Capital II and TCS Capital, TCS GP has the sole power to vote and dispose of the 3,005,246 shares of Common Stock beneficially owned by it. As the principal of TCS GP, Eric Semler has the sole power to vote and dispose of the 3,005,246 shares of Common Stock beneficially owned by him. As the direct owner, TCS Offshore has the sole power to vote and dispose of the 1,817,759 shares of Common Stock it holds.
