  - (2) Mr. Berger's 326,158 shares include his 2008 time-vesting restricted stock unit award of 48,100 units, which vested on March 2, 2009; and his 2009 time-vesting restricted stock award of 232,558 shares, which will vest on March 15, 2010.
  - (3) Each warrant entitles Mr. Berger the right to purchase one share of Boise Inc. common stock.
