- (2) Between January 1, 2015 and December 31, 2015, Mr. Buhr acquired a total of 512 shares of 1st Source Corporation common stock under the 401(k) Plan through normal contributions and a 10% stock dividend declared by 1st Source Corporation on July 22, 2015, payable to all holders of common stock on August 15, 2015.
