The lapse of Geron's repurchase right is conditioned on the optionee continuing to provide services to Geron through each vesting date.
- (2) The shares of restricted stock will remain subject to a repurchase right of Geron over four years, during such time the repurchase right will lapse with respect to 25% of such shares on each anniversary date of the date of grant. The lapse of Geron's repurchase right is conditioned on the optionee continuing to provide services to Geron through each vesting date.
- (3) Shares issued in lieu of cash payment for annual board of directors retainer fee. Number of shares issued based on close price on May 23, 2007 of \$9.32 per share.
