The number of shares of common stock owned does not reflect ownership of RSUs because the number of RSUs will be determined based on a ten trading day value weighted average price of R. R. Donnelley & Sons Company ("RRD") common stock following the date of grant. Mr. Pecaric's RSUs will vest ratably in three equal installments on the first three anniversaries of the date of grant, subject to Mr. Pecaric's continued employment with RRD. Number of shares of common stock includes 3,790 shares of common stock owned individually and 365 shares of common stock held jointly with spouse. The Reporting Person will amend this Form 4 when such information is available.
