Item 1.01 Entry into a Definitive Material Agreement

On November 18, 2013, Tanger Factory Outlet Centers, Inc. (the "Company"), and its operating partnership, Tanger Properties Limited Partnership (the "Operating Partnership"), entered into an underwriting agreement (the "Underwriting Agreement") with Jefferies LLC, U.S. Bancorp Investments, Inc. and Wells Fargo Securities, LLC, pursuant to which the Operating Partnership agreed to sell \$250.0 million in aggregate principal amount of 3.875% Senior Notes due 2023 (the "Notes"). The Notes were offered and sold under a prospectus supplement and related prospectus filed with the Securities and Exchange Commission pursuant to a shelf registration statement on Form S-3.
