The Reporting Persons further reserve the right to act in concert with any other shareholders of the Issuer, or other persons, for a common purpose should it determine to do so, and/or to recommend courses of action to the Issuer's management, the Issuer's Board of Directors, the Issuer's shareholders and others.

Item 5. Interest in Securities of the Issuer.

(a-e) As of the date hereof, Fairholme may be deemed to be the beneficial owner of 38,258,648* Shares (27.7%) of the Issuer, the Fund may be deemed to be the beneficial owner of 34,426,276* Shares (24.9%) of the Issuer and Bruce R. Berkowitz may be deemed to be the beneficial owner of 38,258,648* Shares (27.7%) of the Issuer, based upon the 137,939,276 Shares outstanding.**
