(the "Issuer") and HMC Atlas Air, HMC Atlas Air sold 4,000,000 shares of the Issuer's common stock, par value \$0.01 per share (the "Common Stock"), to the Underwriters, which sale was consummated on May 18, 2009.
 - (6) Pursuant to the Underwriting Agreement, HMC Atlas Air also granted the Underwriters a 30-day option to purchase 600,000 additional shares of Common Stock (the "Option"). On May 18, 2009, the Underwriters partially exercised the Option and purchased 440,848 shares of Common Stock, which purchase was consummated on May 20, 2009.
