This Amendment No. 3 (this Amendment) reflects changes to the information in the Schedule 13D relating to the Ordinary Shares, par value \$0.01 per share (Ordinary Shares) of eLong, Inc. (the Company), filed January 27, 2009 by the Reporting Person as amended by Amendment No. 1 to Schedule 13D filed on March 25, 2009 and Amendment No. 2 to Schedule 13D filed on April 30, 2009 (as amended, the Schedule 13D). All capitalized terms used in this Amendment and not otherwise defined herein have the meanings ascribed to them in the Schedule 13D. Except as otherwise provided herein, each Item of the Schedule 13D remains unchanged.

Item 3. Source and Amount of Funds or Other Consideration.

Item 3 of the Schedule 13D is hereby amended and restated in its entirety as follows:

As of June 9, 2009, the Reporting Person purchased an aggregate of 6,229,270 shares of Ordinary Shares for an aggregate purchase price of approximately \$21.3 million using working capital.

Item 5. Interest in Securities of the Issuer.

Item 5 of the Schedule 13D is hereby amended and restated in its entirety as follows:

(a) As of the date of this report, the Reporting Person beneficially owns an aggregate of 6,229,270 shares of the Company's Ordinary Shares, which represents 27.9% of the 22,318,501 shares of the Company's issued and outstanding Ordinary Shares as reported in the Company's Form 20-F filed for the fiscal year ended December 31, 2007.
