- (2) Includes (i) 3,271,234 shares of Carnival Corporation Common Stock held by the Nickel 2003 Revocable Trust, (ii) 841,506 shares of Carnival Corporation Common Stock held by the NA 2008 Trust and (iii) 841,506 shares of Carnival Corporation Common Stock held by the KA 2008 Trust.
